



## Memorandum of Understanding

between

THE NATIONAL RESEARCH COUNCIL OF ITALY

and

THE COMMONWEALTH SCIENTIFIC AND INDUSTRIAL RESEARCH ORGANISATION

The National Research Council of Italy (**CNR**) and the Commonwealth Scientific and Industrial Research Organisation (**CSIRO**), hereinafter referred to as "the Parties",

**CONSIDERING** that CNR in Italy and CSIRO in Australia are major research organizations in all fields of knowledge and they have common interests and objectives in advanced scientific research;

**DESIRING** to promote, develop and strengthen the relationship between scientists from both countries;

**RECOGNIZING** the importance of encouraging collaboration in areas of mutual interest and benefit to both Parties;

Agree to as follows:

### ARTICLE 1

#### Objective

The objective of this MoU is to establish collaboration between CNR and CSIRO and to facilitate discussions for specific programs of collaboration on a basis of equality and mutual benefit, as well as to promote and support cooperation between qualified scientists in fields of most interest to both Parties.

### ARTICLE 2

#### Cooperation Areas

To achieve the objective referred on Article 1, the Parties shall:

- i. encourage joint research activities in the areas of:
  - a. Earth observation for inland, coastal and marine ecosystems as well as terrestrial and atmospheric Earth observation;
  - b. genetics/breeding for improved grain quality and disease resistance in wheat;
  - c. grapevine research; and
  - d. advanced materials, nanoscience and nanotechnology;
- ii. encourage the exchange of information and materials under a separate legally enforceable arrangement; and
- iii. identify other areas of possible interest and collaboration.

It must be noted that each Party will designate a coordinator who will be responsible to follow up the activities related to this MoU.

The expansion of cooperative areas and activities is to be further discussed based on the needs and interest of both Parties.

The Commonwealth Scientific and Industrial Research Organisation designates the Europe Advisor, CSIRO International.

The National Research Council of Italy designates the International Relations Office.

### **ARTICLE 3**

#### **Funds**

The implementation of this MoU will be through a separate Cooperation Program describing scope of activities, such as seminars, workshops and joint projects, and will be determined by funds regularly available at both institutions for the types of collaboration undertaken and by such other financial assistance as may be obtained by either institution from external sources. Notwithstanding anything contained in this MoU, each Side retains its autonomy to conduct research independently of this MoU.

### **ARTICLE 4**

#### **Intellectual Property Right**

Each Party's rights, title and interest in its intellectual property and confidential information remains unaffected by the existence of this MoU.

Scientific outputs in the framework of this MoU will be subject to mutual Intellectual Property Right and patenting. All of the benefits resulting from co-operations in the framework of this MoU will be shared and negotiated through a separate agreement.

## ARTICLE 5

### Duration

Upon signature by each Party, this MoU shall come into effect for a period of five years or until otherwise terminated earlier in writing by either Party. Extension, modifications or other changes may be made as agreed to by both Parties. Termination will incur no liability on either side, and will not affect any agreements or other legally-binding arrangements in place between the two Parties.

## ARTICLE 6

### Record of Intentions


