CONTRACT

The Embassy of Italy in Canberra (hereinafter referred to as “the Embassy”) hereby accepts the quotation dated 01/01/2017 submitted by Rentokil Australia Pty. Ltd. (hereinafter referred to as “Rentokil”) for the general pest prevention to all internal and external spaces (inclusive of garages) at the Italian Embassy, Chancery Building, located at 12, Grey Street, Deakin, Canberra, 2600 for the period 1 January – 31st December, 2017.

The terms and conditions are mutually agreed to be as follows:

1. The total cost of the pest control services outlined in the above mentioned quotation which forms an integral part of the present agreement amounts to AUD. \$ 814.00 (eight hundred fourteen dollars only) which amount is agreed to be inclusive of the local GST (AUD \$.74.00) payable under the present agreement.
2. The description of services rendered to the Italian Embassy in Canberra (Chancery Building) outlined in the aforementioned quotation in the scope of services is as follows:
survey of premises and recommend 2xVPA pest prevention to all internal and accessible external areas for the control of cockroaches, rodents, webbing spiders and textile pests.
3. Rentokil Australia undertakes to comply with the terms of the works agreement and in the event of breach on the part of the Company the Embassy has the right to give written notice of rescission of this contract.

4. Payment of the contract price will be effected on quarterly instalments the end of the pest control services rendered upon receipt of four invoices per annum for the amount of AUD. \$ 203,50 each (inclusive of GST) issued to the Italian Embassy in Canberra and after acceptance of the satisfactory assigned services;
5. Should any dispute arise between the contracting parties with regard to the interpretation, execution or resolution of this contract which cannot first reasonably be settled as between them shall be referred for judgment to an independent Arbitrator, appointed by mutual consent and the parties further agree to adhere to the Arbitrator's decision as being final.
6. Throughout the execution of the aforementioned services the Company must respect the agreement established herein and conform to the Italian regulations, as much as they are compatible with the current legislations and regulations. Should the Company fail to observe the conditions and the agreement here established of the aforesaid standard and regulations this Embassy can arrange otherwise for the completion of the services at the Company's sole risk and rescind the obligation by means of a simple statement to that effect.
7. The Embassy avails itself the right, at his unquestionable discretion, to terminate this agreement in the event of misconduct of the Company to perform the works agreed upon, and submit claims for damages against the Company, which will be responsible for supplementary expenses incurred by the Italian Embassy in finding another local Pest Control Company for the rendering of the services included in the scope outlined in the aforementioned quote to be performed in the Chancery premises at the Italian Embassy in Canberra.
8. Privacy Act 1988 – in signing this contract you accept that the Embassy of Italy may publish on its website details pertaining to the contract between us, including the name of your Company and its representatives, the services you have performed for us and monies paid for such services.

This contract is engrossed in duplicate for signature by the said parties in acknowledgment and acceptance of the conditions contained herein.
